The Tender documents can be obtained from the Works Wing Branch PESSI Head Office, Lahore from the date of publication on written request on firm letter pad of company/firm by showing original documents such as enlistment/renewal letter, original partnership deed of the firm/contractor, original NIC card of the proprietor/contractor of the firm, in case of authorized person his authority letter on stamp paper with his original NIC.

Tender will not be issued to those contractors whose performance of work remained unsatisfactory during the previous year or failed to complete the previous works, which might be certified from Engineer Incharge.

The contractor would be eligible for issuance of tender who have valid PEC Certificate in original for the year 2021-22 and registered with Punjab Revenue Authority (PRA). The firm/contractors shall provide certificate that they are not involved in any type of litigation with Government Department/Autonomous Bodies in the Court of Law and no special report of inspection against them.

Tender will be received in the Committee Room PESSI, Head Office Lahore and opened on fixed date and Time by the tender opening Committee in presence of bidding firms or their authorized representative who care to present. The tender procedure will be adopted as per PPRA rules 2014 under single stage one envelope procedure. Tenders can be seen on PPRA Web-Site: <http://ppra.punjab.gov.pk/>.

Conditional tenders will not be entertained. The earnest money @ 5% of the estimated cost in the shape of CDR/bank draft of any schedule bank of Pakistan in favour of Commissioner PESSI should also accompany the tender.
